Exercise Update

Paul Parsons/ Wanda Roberts

- ASPR is requiring an evacuation exercise that must reach 20% of our regional staff bed numbers. Turkey Creek Medical Center, Parkwest and Blount will be the evacuating facilities (that will be about 500 beds). Exercise plan is to give a 60 minute window and then progress through the evacuation with specific timelines. Facilities will work as they normally would to evacuate, then when those avenues are exhausted, they will contact RMCC/RHC as they normally would. We will be contacting the rest of our Coalition hospitals, looking for bed placement for evacuating patients and transfer.
- There is a required toolkit that will be used during the exercise.
- If you aren't evacuating, you should plan on participating by accepting patients. We will discuss specific processes as date approaches.
- This is a low notice exercise, but date range will be provided to you.
- We would like all facility leadership to participate in hotwash.

Stop The Bleed Discussion

A couple of weeks ago Charity and Wanda met with Debbie Tuggle and Gigi Taylor from UTMC. They have been doing a lot of community "Stop the Bleed" trainings. They would like to partner with the KETHC to expand this project to the regions.

They will be proposing that the KETHC assist in finding a representative from each county to become certified (we would like this to be a hospital and EMS rep). Then that person will go to their local schools and do the training. The Coalition will provide funding to leave a "Stop the Bleed" kit at the school after the training has been done. This would be a great way to promote community awareness of the coalition and the role of the hospital in it's community.

John Brinkley discussed those who can be certified as trainers. Roles have recently changed, so we will get complete listing of who can teach this course later. The training consists of a slide show that lasts maybe 30 minutes, then hands-on demonstration.

- Marcus Sheppard: National Healthcare Coalition Conference in San Diego: Having face to face meetings and knowing you community partners is vital. He would like to see more education for new personnel in the field of emergency preparedness and compliance regulations.

 - Wanda gave overview of the session. Entire group met in one room, and then split into different groups for more specific information/feedback.
 - Jan Sneed (Group 2 Home Health, Hospice representative). Discussions are more pertinent and manageable with groups being split. She looks forward to being part of the Coalition and learning what is being done in the community.

Ongoing Surge Event**Wanda Roberts**

Update from facilities indicated there are still critical capacity issues. Group consensus was to continue HRTS reporting 4 times/day. AMR Knox County – There are ED delays. AMR currently has a surge program with UT, Fort Sanders and PRMC – if they get patients waiting more than 2 hours, they will start offloading patients and leave one staff per 5 patients (at times, that’s 3 or 4 hours they may have to wait but it gets trucks back in service). Steve Hamby requested facilities show patience when waiting for EMS transport, as they are busy too.

- Wanda reminded group that cache ventilators are available if needed.
- Rose Meza reminded group that skilled nursing facilities could be looked at for bed placement if needed.
